Dear Ms. Mantana: Greetings: Thanks for your response. I'll pass on you good wishes to Vira.

At 9:30 a.m. this morning we had finally had success in sending you the 6 page fax from last week concerning the letters of invitation for Dr. Arjuna and Dr. Pairote as well as their proposed travel schedule. Please let us know if the travel schedule is acceptable, as we will need to confirm with our travel agent in order to get the special rates.

Prof. Barta: The Thai Embassy in Toronto will not issue a visa for more than 90 days for anyone travelling to Thailand. Peter obtained visa(s) for he and his wife fairly close to the time he was travelling. I have no idea if he mentioned to the authorities that he would be in Thailand on a 14 week assignment, therefore requiring more than the 90 day visa.

I have mentioned this situation to D. Goff, who is also coming to SUT this fall for 14 weeks (over the 90 days). I've asked him to take the CIDA support letter and make a specific request of the Embassy so that he can have his visa authorized for the number of days he is on assignment in Thailand. We see it as a project responsibility. I will likely speak to the Embassy in Toronto and/or follow up with ARA Associates to see if they can assist with settling Peter Barta's penalty claim re: visa.

Do you have a current address, contact name, fax and phone number for the Canadian Embassy in Bangkok. We are trying to fax the letters of
